Regulation of the Bavarian capital of Munich regarding the Olympic park event locations (Olympic Park Regulation)

of 25th November, 1996

Resolution of the city council: 21/11/1996

Under Art. 23 Para. 1 and Art. 38 Para. 3 No. 1 of the Act regarding state penal law and the regulation on public order and security (LStVG, State Penal and Administrative Order Act) as amended in the publication of 13 December 1982 (BayRS 2011-2-I), last amended by the Act of 25 June, 1996 (GVBI., Journal of Laws and Ordinances, p. 222), the City of Munich hereby adopts the following regulation:

§ 1 Scope

The regulation applies to the following enclosed event locations of the Olympic Park: The Olympic Stadium, including the warm-up area and Werner-von-Linde Hall, Olympic Hall, Olympic Swimming Pool and its sunbathing lawn, Olympic Ice Sports Centre, Olympic Tower, Olympic Velodrome.

§ 2 Visiting the event locations

- (1) Only persons possessing a valid admission ticket or other pass, or who are able to provide other evidence of their right to enter, may visit the event locations of the Olympic Park as spectators. Tickets or passes are to be provided to ticket inspection personnel or police on request. Spectators shall only occupy the seat specified on the admission ticket for the relevant event, § 4 Para. 3 remains unaffected.
- (2) Ticket inspection and security personnel are also entitled to search persons, using technical aids if necessary, to determine whether they present a risk to security due to alcohol or drug consumption or the possession of weapons or dangerous/combustible materials. Searches also extend to items carried by persons.
- (3) Persons who are not able to provide evidence of their right to enter and persons presenting a risk to security are to be turned away and prevented from entering the event locations. This also applies to persons against whom an access injunction has been issued within the Federal Republic of Germany.

§ 3 Conduct in the event locations

(1) Within the Olympic Park event locations, each visitor shall conduct him/herself in such a way that no other person is placed at risk or in danger or – except to the extent made unavoidable by the circumstances – impeded or inconvenienced.

- (2) In particular, visitors to the event locations are not permitted to:
- a) access areas which are unauthorised for visitors;

- b) climb on or over structures or facilities not intended for general use, particularly façades, fences, walls, cornices, playing field enclosures, lighting systems, television broadcasting platforms, trees, masts of any sort, roofs or tented roof constructions including bracing cables and anchorages;
- c) sit or stand in walkways intended for accessing, entering and exiting visitor seating areas or occupy emergency exit routes;
- d) throw items onto playing fields or visitor areas;
- e) carry bulky items (e.g. ladders, stools, boxes, suitcases);
- f) carry bottles, cups, jugs or cans made of breakable, splintering or especially hard material;
- g) carry aerosol spray cans with harmful materials, corrosive or colouring substances; items which could be used as cutting, thrusting or stabbing weapons or as projectiles; or flag or banner poles with a length greater than 1 m or a diameter greater than 3 cm;
- h) bring animals into the event locations;
- i) tread upon areas planted with flowers or shrubs;
- k) set fires;
- l) carry, burn or set off fireworks, pyrotechnic articles or flares;
- m) write on, paint, or apply paste to building structures, other fixtures or pathways;
- n) relieve themselves outside of the toilets or otherwise soil the event locations by other means, particularly by littering;
- o) carry in alcoholic beverages of any sort;
- p) sell goods and admissions tickets without the consent of the operators of the event locations, distribute printed printed materials or organise collections.

§ 4 Ad-hoc directives

- (1) The City of Munich may issue ad-hoc directives for the purpose of enforcing § 3 Para. 2 item k) in order to prevent hazards to life, health, property or possessions arising from the risk of fire.
- (2) Visitors shall comply with the directives of the police, fire services, ticket inspection, security and rescue personnel as well as those of the stadium announcer.
- (3) In order to prevent threats related to security or of a technical nature, visitors are required to occupy seats other than those specified on their admissions tickets including in other blocks when instructed to do so by police or ticket inspection/security personnel.

§ 5 Infringements

- (1) According to Art. 23 Para. 3 of the LStVG, fines may be imposed upon any person who
- 1. contrary to § 2 Para. 1 sentence 1 remains as a spectator in the event locations of the Olympic Park without evidence of permission to enter,
- 2. contrary to § 2 Para. 1 sentence 3 occupies a seat as a spectator other than that specified on their admissions ticket for an event,
- 3. contrary to § 3 endangers or injures others through his/her behaviour in the event locations of the Olympic Park, in particular any person who violates the provisions contained in § 3 Para. 2 items a) through i) and I) through p) regarding conduct in the event locations.
- (2) According to Art. 38 Para. 4 LStVG, fines may be imposed upon any person who, wilfully or negligently,

- 1. sets a fire in the event locations of the Olympic Park, contrary to § 3 Para. 2 item k),
- 2. does not comply with enforceable directives according to § 4,

- (3) In addition, persons violating the provisions of this Regulation can be removed from the relevant event facility and issued an entry ban, without reimbursement. In this case, any annual or season tickets are to be returned to the issuer.
- (4) Other provisions relating to the payment of fines, particularly those regarding the use of pyrotechnic articles or the relevant provisions of the Weapons Act which prohibit the carrying of firearms or side weapons, remain unaffected.

§ 6 Entry into force

- (1) This regulation shall enter into force on the date following its publication.
- (2) The Regulation of the City of Munich regarding the event locations in the Olympic Park (Olympic Park Regulation) of 21 December 1976 (MüABI. p. 261) shall simultaneously be repealed.
